## Financial Policy

Because insurance policies change and Shore Pulmonary participates with numerous carriers, **you need to understand your own plan's benefits**, as well as financial responsibilities such as co-pays, deductibles and co-insurance.

Some insurance plans require a **referral** from your Primary Care Physician (PCP) in order to be seen by any Specialist. This must be obtained 72 hours prior to your visit. It is your responsibility to confirm that the referral has been issued because **Shore Pulmonary will not be able to treat you without the referral in place and your appointment will be re-scheduled.**

If we do not participate with your insurance plan, we will gladly provide you with an itemized receipt for your full payment at the time of service.

For missed appointments or any appointments not canceled at least 24 hours in advance of the visit, we reserve the right to charge for reserving a slot for you.

Past due balances must be paid in full before future appointments can be made. You are responsible for the fees of any collection agency and any and all costs/expenses incurred (including attorney fees) in the collection of your owed amount.

Our offices accept Cash, Checks and most major credit cards.
